**Objectives. The Parties agrees as follows:**

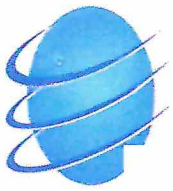
1. The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfillment of the purpose of the MOU.

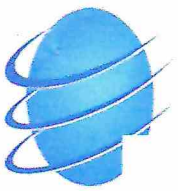

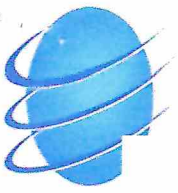

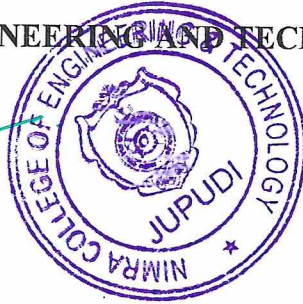
