1. Administration:

- a. The college website serves as a central platform for disseminating administrative information and notices related to student affairs. Regular updates on placements, conferences, workshops, and committee-related activities (such as student welfare and grievance) are provided. Additionally, the website hosts academic calendars, examination schedules, semester results, and other pertinent information.
- b. Various data pertaining to faculty, student enrollment, program details, examination outcomes, educational finances, and infrastructure are submitted. Educational development indicators like Institution Density, Gross Enrollment Ratio, Student-teacher ratio, and Gender Parity Index Per Student are monitored. 2. Finance and Accounts:

- a. All financial transactions, including payments and receipts, are managed using Tally-9 software, which is subjected to thorough auditing by competent professionals.
- b. The institution has successfully implemented a cashless fee payment system through POS terminals and Unified Payments Interfaces (UPI) like Paytm, Phone Pay, and internet banking. A majority of students prefer this online fee payment method.

3. Student Admission and Support:

4. Examination:

- a. The college website hosts internal examination schedules, while internal marks are uploaded on the University portal. External practical examination schedules are also posted online, and both internal and external marks are submitted to the University portal. Ultimately, examination results are accessible to students via the University portal, which is also displayed on the college website.
